DESPITE THESE COVID-19 PRESSURES, WE PASSED AND SECURED GOVERNOR NEWSOM'S APPROVAL OF FIVE OF OUR SPONSORED BILLS. BEYOND THAT, WE CONTINUED OUR LONG-STANDING COMMITMENT TO RACIAL EQUITY AND REFORMING THE JUSTICE SYSTEM BY ADVOCATING FOR A COMPREHENSIVE PACKAGE OF BILLS AND CONSTITUTIONAL AMENDMENTS THAT CENTERED THE CALIFORNIA LEGISLATIVE BLACK CAUCUS'S PRIORITIES. THIS INCLUDED PRIORITIZING A PACKAGE OF RACIAL JUSTICE LEGISLATION IN SACRAMENTO, INCLUDING 14 BILLS AND 2 PROPOSED CONSTITUTIONAL AMENDMENTS TO REPEAL PROP 209 (WHICH BANNED AFFIRMATIVE ACTION) AND TO RESTORE VOTING RIGHTS TO PREVIOUSLY
